In terms of Sec 115 BAC under Income Tax Act.1961, with effect from the Financial year 2020-2021, all the employees / officers are required to exercise their option for deduction of the TDS as per either OLD regime / NEW regime in a prescribed format which is enclosed, which should be submitted latest by 31-08-2020.

If option 1 i.e., old regime is exercised, such officer / employee has to submit form 12 BB and the format for the same is also enclosed, which should be submitted latest by 31-10-2020.

All controlling officers/Supervisors are advised to circulate the above instructions to staff under their control and the declaration form obtained and sent to the Personnel Department (Bill drawing Office) in one bunch to take further action by the bill preparing official.
