As per RBE 34/2023 the benefit of reckoning of 30% pay element for the purpose of fixation of pay of running staff on their promotion/appointment to the posts filled through general Section is not admissible. Further, the general selection is voluntary in nature and the concerned staffs are aware of mode of fixation of pay on promotion/appointment to a post under General Selection. Hence in such cases, pay fixation has to be effected without taking into account the 'pay element'.

It is to be noted that mere securing qualifying marks in the CBT examination will not confer any right / guarantee for selection and to be placed in the panel. The final selection and placement in the panel are subject to other parameters involved in the selection process.
