1	<b>Eligible staff to apply</b>	The list of senior most eligible staff working as Sr. Technicians & Technician-I of respective Loco Sheds of Chennai Division in Level 6 & 5 of VII PC Pay Matrix and who are in the normal zone of consideration in 1:3 ratio based on their integrated seniority published vide ref(2).above and who have communicated their willingness are alerted to be in readiness for the written examination scheduled to be held shortly is enclosed in <b>Annexure-I</b> .
2	<b>Date of examination</b>	The date, venue and time of written examination will be intimated in due course
3	<b>Medical Fitness</b>	Fitness in AYE THREE medical classification is mandatory for the post of JE/TRS Loco Shed.
4	<b>Syllabus</b>	The syllabus prescribed for selection to the post of JE/TRS Loco Shed Promotional Quota (PBC 285/2024) is enclosed as <b>Annexure II</b> .

5	<b>Pre-Promotional Training</b>	<p>Pre-promotional training will be organized by the Controlling Officer covering the syllabus for prescribed period for employees belonging to SC/ST communities - in terms of Railway Board's letter No.96-E(SCT)-1/80/1 Pt.XVII dated 15.12.1997 (RBE 174/1997).</p> <p>JE/ELS/AJJ- PPT will be imparted to SC employees only as the vacancies are earmarked for SC only.</p> <p>JE/ELS/RPM- PPT will be imparted to ST employees only as the vacancies are earmarked for ST only.</p> <p>In case, if any <b>SC/ST</b> employees express unwillingness for PPT, a written declaration to that effect may be obtained and forwarded to this office for record.</p>
6	<b>Mode of selection</b>	<p>The selection will consist of written examination and perusal of record of service in terms of Railway Board's letter No.E(NG)2000/PN1/41 dated 07.08.2003. Seniority is also a component of the selection.</p> <p>A candidate has to obtain a minimum of 60% marks in Professional Ability i.e. in written examination for being considered for further selection process of perusal of Service Record. (APAR, Education Qualification, Penalty/Award)</p> <p>The post of Junior Engineer/Loco sheds being classified as Safety Category post, there is no relaxation in qualifying marks to employees belonging to the category of SC/ST and hence they are also required to secure 60% marks in the written examination</p>
7	<b>Procedure for Centralized Computer Based Test (CCBT)</b>	<p>The selection consists of written test as per Board's letter No.E(NG)/1/2018/PM1/4 dated 14.12.2018 (RBE 196/ 2018). The Question Paper will be 100% Objective type multiple choice questions.</p> <p>In terms of PBC.No.205/2016, 10% of the total marks will be set on <b>Official Language Policy and Rules</b>. But the questions on the same will not be of compulsory in nature and is purely optional.</p> <p>In terms of PCPO/MAS Letter No. P(R)608/P/Vol. XV(OL) dated 28.06.2019, Question Papers will be in Trilingual (English, Hindi &amp; Tamil language) for the selection.</p> <p>In terms of Railway board letter No.E(NG) 1/2018/PM 1/4 dated 14.11.2019 (RBE 194/2019) there will be <b><u>no negative marking for wrong answer in selections</u></b> against departmental quota where panel is arranged in the order of seniority from those qualified.</p> <p>The written examination will be conducted in Centralized Computer Based Test mode.(PBC.02/2025)</p> <p>Electronic devices will not be allowed inside the examination hall and the <b><u>violators of the above guidelines will be taken up under DAR.</u></b></p> <p>In terms of Para 3 of RBE No: 122/2023 in case of the question(s)/answer(s) in the Questions paper are incorrect, the procedure as prescribed in the RB letter No. 2010/E/(RRB)25/27 dated: 09.06.11 is to be adopted only for those candidates who have attempted that/those incorrect question(s) or question(s) with wrong answer(s).</p>
8	<b>Supplementary examination</b>	<p>In terms of IREM Para 223(1) (i) (a) to(c), Supplementary written examination will be conducted only for those employees who are not able to attend the main examination due to following circumstances.</p> <ol style="list-style-type: none"> <li>I. Those who could not be relieved due to Administrative reasons (or)</li> <li>II. Sickness(RMC) of the employee (or)</li> <li>III. Any other reason which is beyond the control of the employee</li> </ol>

9	<b>Procedure for Drawal of Panel</b>	A candidate must secure a minimum of 60% marks in the Professional Ability and 60% marks in the aggregate for consideration of placement in the panel and the final empanelment is subject to the availability of vacancies ( <b>PBC 50/2006</b> ). The names of the selected candidates will be arranged in the order of seniority but those securing a total of 80% or more marks in the aggregate will be classified as 'OUTSTANDING' and placed in the panel appropriately in the order of their seniority allowing them to supersede not more than 50% of total field of eligibility.
10	<b>Training after empanelment.</b>	The empaneled employees should undergo training for prescribed period.
11	<b>Notifying the staff</b>	Wide publicity should be given amongst staff mentioned in Annexure-I. The copy of notification should be displayed on notice board and the Supervisor concerned should ensure the same. If any complaint is received from the employees for not being notified of the said notification, supervisory staff concerned will be held responsible.

## **SYLLABUS FOR THE POST OF JE/TRS(PQ)/ Loco Sheds**

### **I. GENERAL:**

- 1 Knowledge of English should be able to carry on- day to day correspondence, submit reports and understand departmental rules safety regulations, etc.
- 2 Should be able to prepare estimates, Schedule of materials and labour for the execution of works, should understand the drawings and sketches and be able to guide and instruct staff under him.
- 3 Should be conversant with the procedure for obtaining and accounting stores, booking of labour and maintaining muster rolls etc.
- 4 Should be conversant with Establishment matters such as DAR, Leave Rules, Pass Rules etc, departmental procedure regarding HOER, Factories Act, Booking of overtime and Stores matters etc.

### **II. OFFICIAL LANGUAGE POLICY AND RULES:**

### **III. TECHNICAL:**

- 1 Should know the principles of electro-magnetism, details of construction and application to various types of electrical machines and appliances should as motors, transformers, Relays etc.
  - 2 Should be fully conversant with different types of windings used in armatures of DC motors and generators & stators and rotors of AC Machines.
  - 3 Should be able to test, locate and rectify faults in armature and field coils of electrical machines and accessories.
  - 4 Should know uses of various types and sizes of wires and cables, their current carrying capacities, different types of installations, windings, binding, baking, shellacing, varnishing etc., including Y, A, B, C, E, F & H class insulation.
  - 5 Should be familiar and conversant with the various types of measuring and testing Instruments.
  - 6 Should be fully conversant with operation and Maintenance of machinery such as pumps, transformers, motors, starters and associated protective devices.
  - 7 Should be proficient in the details of and the electric traction equipment in locomotives
  - 8 Should be familiar with Fire detection unit, flasher and safety item provided in Locos.
  - 9 Should be able to test all control and power, control and auxiliary circuits of conventional as wells as Three phase Locos.
  - 10 Should be familiar with activities involved in Trip, IA, IB, IC Inspection Schedules and TOH/IOH/POH schedule maintenance (Electrical, Pneumatic, Mechanical and Testing portion complete).
  - 11 Should be conversant with all type of brake system in both Locos and EMUs
  - 12 Should understand Latest developments in LOCO like KAVACH, VCB, SIV, FDCS and VCD etc.
  - 13 Should be familiar with basic functions of GTO/IGBT, SR, BUR, VCU and its working in Three Phase Locos.
  - 14 Should understand the drawing and specifications of mechanical components of rolling stock
  - 15 Should be proficient in the repairs of mechanical components of rolling stock such as bogies, under frames, axle boxes, brake gear, draft and buffer gear, body repair work etc., and be conversant in standard moving dimensions, condemning Size of wheels etc.
  - 16 Should be thoroughly conversant with re-metaling of-suspension bearings and overhauling procedure of-Axle Roller bearings.
  - 17 Should be well conversant with safety precautions, rules for safe working on Electrical equipment , GRS for 25 KV OHE traction system, TXR hand book and First aid procedure etc.
  - 18 Should be conversant with the working principle of Air Compressors, Air Dryer, Pantograph, Brake Cylinders, pneumatic gauges, pressure switches, safety valves, brake controller, brake electronics & Parking brake etc. for conventional and Three phase Locos.
  - 19 Should be conversant with the Brake testing of conventional and three phase Locos.
