1	Application	Assistant/S&T of Signal and Telecom Dept, MAS Division fulfilling the following criteria on the date of notification are advised to submit their application only through online in the following link. https://pbmas.in/notifications/	
2	Eligible staff to apply	Assistant/S&T of Signal and Telecom Dept. having lien in MAS Divn. and fulfilling the following Educational Qualification, Age & Service conditions are only eligible to apply.	
3	Age/Service conditions	Assistant/S&T of Signal and Telecom Dept who have completed three years of regular service and age not more than 45 years (SC/ST candidates age relaxation as applicable) as on the date of the notification in S&T dept. of Chennai Division. (RBE52/2024).	
4	Educational Qualifications	(A) Matriculation/SSLC plus ITI certificate from recognized institutions of NCVT/SCVT in the trades of Electronics Mechanic/Electrician/Wireman (OR) Matriculation / SSLC plus Course Completed Act Apprenticeship in the trades mentioned above (OR) (B) 10+2 with Physics and Math (RBE 52/2024).	

12		BEE ONE (B-1) medical classification is required for the post of Tech III/Tele.
11	Supplementary examination	There will be no Supplementary written examination being an LDCE Selection.
10	Computer Based Test (CBT) Examination	 (i) The selection consists of CBT examination. The Question Paper will be 100% Objective type multiple choice questions. (ii) In terms of PBC.No.205/2016, 10% of the total marks will be from <i>Official Language Policy and Rules</i> (which will be optional). (iii) In terms of Railway board letterNo.E (NG) 1/2018/PM 1/4 dated 14.11.2019 (RBE 194/2019) there will be <u>negative</u> marking @ 1/3 mark for a wrong answer for LDCE Selection where panel is arranged in the order of merit from those qualified.
9	Mode of selection	The written examination will be conducted in Computer Based Test mode. The duration of CBT examination will be 2 hrs.All the staff who have volunteered and fulfill the eligibility conditions prescribed thereon would be subjected for a selection. The candidate has to obtain a minimum of 60% marks in professional ability for further selection process.As Tech.III/Telecom of S&T dept. are classified as "safety category posts ", there is no relaxation in the qualifying marks of employees belonging to the category of SC/ST.
8	Pre- promotional/ training to eligible SC/ST employees	Pre-promotional training to eligible 'SC' & 'ST' employees covering the syllabus of the examination will be organized and imparted by the Branch Officer for prescribed period. (RBE 174/1997). After completion of pre-promotional training, a certificate should be issued by controlling officer that all the eligible employees have been imparted the pre-promotional training for the prescribed period. If any eligible employee belonging to reserved community expresses unwillingness for PPT, a written declaration to that effect may be obtained and forwarded to this office for record.
7	Syllabus	The syllabus for selection to the post of Tech. III/Telecom against 25% LDCE quota are enclosed as Annexure-B (PBC 155/2024).
6	Staff joined on request transfer on bottom seniority in this Division.	Service rendered by them in the old unit will be reckoned for determining their eligibility in the new unit subject to the condition that the service so allowed to be counted does not exceed the length of service of their immediate senior in the new unit (RBE 34/2006). The service rendered in the old unit will count for purpose of qualifying service for promotion in new unit provided:- (i) he is otherwise eligible to be considered for the selection to Group 'C' posts as per the extant rules; and (ii) the category in which he was working in the old unit is an eligible category for the selection/post in the new unit also.(RBE 99/2006).
5	Cut-off date	The cut-off date for determining the eligibility of the employees will be the date of issue of notification (RBE 117/2006).

13	Empanelment/ Training	The selected staff shall undergo training for one year (52 weeks) out of which 17 week shall be institutional training and 35 weeks field training. (RBE 52/2024).
		As the final panel will be drawn on the basis of merit, there will be no classification as "Outstanding".
14	Notifying the staff	Wide publicity should be given amongst eligible Assistants of S&T dept. of MAS divn. The copy of notification should be displayed on notice board at a conspicuous place. All i.e. Supervisors concerned should ensure the same. Staff who are on deputation/leave/sick should also be notified to enable them to submit their applications through proper channel in time. It is the responsibility of the Supervisor concerned to bring the notification to the notice of staff on deputation/leave/Sick under clear acknowledgement and should be forwarded to this office without fail. If any complaint is received from the employees for not being notified of the said notification, supervisory staff concerned will be held responsible.

Fill in the details as asked for in the online portal. 2. Download the filled in application. 3. Affix photograph, sign and date. 4. 16.	Invalid Application	 Applications not uploaded within the closing time/date. Application without signature or with signature in capital letters. Application uploaded without sign and seal by the Supervisor/Controlling officer as applicable. Application without mandatory enclosures. Variation in the information furnished in the application versus the documents enclosed. Leaving any column blank in the application form. Suppression of facts or furnishing false information in application. Any other irregularity.

After completely filling the application, the application should be downloaded and forwarding signature of the supervisor should be obtained on the downloaded application.
