3. In terms of PBC No.184/2017 any wrongful excess payment on grant of MACPs detected subsequently will be subject to rectification and recovery.
4. Based on the recommendations of 7th CPC, the benchmark for grant of MACPs has been enhanced from "GOOD" to "Very Good" w.e.f. 25.07.2016.
